This human-led guidance is vital to shaping business students' values and ensuring they understand the broader implications of their decisions in the global market. While AI technologies can augment certain aspects of business education, the human instructor remains at the heart of the teaching and learning experience, providing the mentorship, adaptability, and ethical framework necessary for students to thrive in the business world.

As noted by McMahan and Cech (2019), “While AI can simulate learning environments, it cannot replace the personal connection and the mentorship role that human educators play in shaping students’ intellectual and professional growth” (p. 45). In business education, where soft skills like communication, leadership, and negotiation are essential, this absence of human engagement could undermine the holistic development of students.

Furthermore, AI in education raises ethical concerns, including the potential for bias and fairness issues. AI algorithms, which are often trained on historical data, can perpetuate existing biases present in the data. If AI systems are used to assess student performance or provide recommendations for educational paths, these biases may disproportionately affect certain groups of students, leading to inequitable outcomes (Binns, 2018). Additionally, privacy concerns about the collection and use of personal data are exacerbated when AI systems are involved in managing student information, as these systems often require access to sensitive data for analysis and decision-making (Zhou, 2020).

Despite these challenges, it is important to recognize that AI’s role in education should not be seen as a direct replacement for human instructors. The University of Arizona has implemented an AI-driven platform called Smart Learning, which tailors learning content based on the individual progress and needs of each student. Implement Bias Mitigation Strategies: Institutions should prioritize the use of diverse, representative datasets and involve interdisciplinary teams in AI development to reduce algorithmic bias (AI Now Institute, 2019). Regular audits and impact assessments must be institutionalized to ensure fairness and inclusiveness.

Enhance Data Quality Management: Business education providers must establish strict data governance protocols to ensure the integrity, accuracy, and relevance of training data used by AI systems (Zawacki-Richter et al., 2019). This includes continuous data validation and updating mechanisms.

Retain Human-Centric Roles: AI should be leveraged to support, not replace, the emotional intelligence, mentorship, and ethical guidance that only human educators can provide (Dreyfus, 1992; Selwyn, 2019). Activities that require empathy, critical dialogue, and relationship building must remain human-led.

Foster Critical Thinking and Digital Literacy: Educators should integrate AI literacy and critical thinking modules into curricula, enabling students to question, critique, and appropriately utilize AI outputs rather than rely on them uncritically (Popenici & Kerr, 2017).

Improve Transparency and Accountability: Developers and institutions must strive for explainable AI, where decisions made by algorithms can be understood and questioned by non-technical stakeholders (Burrell, 2016). Policies must be in place to establish clear lines of accountability.
